### JANITORS AND CLEANERS, EXCEPT MAIDS AND HOUSEKEEPING CLEANERS

#### Occupation Description

Keep buildings in clean and orderly condition. Perform heavy cleaning duties, such as cleaning floors, shampooing rugs, washing walls and glass, and removing rubbish. Duties may include tending furnace and boiler, performing routine maintenance activities, notifying management of need for repairs, and cleaning snow or debris from sidewalk.

#### Nature of Work

Janitors and cleaners perform a variety of heavy cleaning duties, such as cleaning floors, shampooing rugs, washing walls and glass, and removing trash. They may fix leaky faucets, empty trash cans, do painting and carpentry, replenish bathroom supplies, mow lawns, and see that heating and air-conditioning equipment works properly. Janitors may wet - or dry - mop floors, clean bathrooms, vacuum carpets, dust furniture, make minor repairs, and exterminate insects and rodents.

#### Distinguishing Characteristics of Levels

*Note: Examples of Work are intended to be cumulative for each progressively higher level of work. The omission of specific statements does not preclude management from assigning other duties which are reasonably within the scope of the duties.*

#### Basic

- Employees in this Role perform routine janitorial services.
- Employees operate and perform routine preventative maintenance on equipment.

#### Operational

- Employees in this Role prepare requests to order supplies and equipment.

- Employees operate and perform routine repairs on equipment; check locks on buildings and windows to maintain security; perform independent janitorial services.

### Recommended Education and Experience for Full Performance

Eighth grade education.

### Minimum Qualifications

### Advanced

- Employees in this Role inspect building areas to ensure that work has been done properly; issue supplies and equipment; inventory stocks.
- Employees estimate needs and prepare purchase requisitions for supplies and equipment; perform specialized janitorial services.
- Employees provide training and assistance to less experienced workers.

Eighth grade education.
