



## CORRECTIONAL SECURITY THREAT INTELLIGENCE (STIU) ADMINISTRATOR

### **General Summary**

Responsible for statewide oversight and coordination of the process of identifying, monitoring, certifying and validating Security Threat Group members, disruptive group members, street gang members and monitoring the daily operations of all STIU Units of the New Mexico Corrections Department and privately operated facilities. Coordinate and facilitate weekly meetings with the STIU Coordinators to share intelligence and determine the dissemination of such intelligence to Federal, State and local law enforcement agencies. Conduct threat assessments and audits at all prisons and provide actions necessary to facility management to enhance security.

### ***Distinguishing Characteristics***

The STIU Administrator will attain, analyze, corroborate and disseminate statewide intelligence through resources and through other agencies to identify threats to the security of the prisons, staff, inmates and the public. The STIU Administrator will manage the coordination of the identification of gang members, gang activity and trends, gang interdiction initiatives and for fugitive apprehension.

### ***Recommended Education and Experience for Full Performance***

Master's Degree in any field from an accredited college or university and ten (10) years of experience in corrections and/or law enforcement, six (6) years of which must have been in the identification of gang members, gang activity and trends and gang interdiction initiatives.

### ***Minimum Qualifications***

Fourteen (14) years of experience in corrections and/or law enforcement; five (5) years of which must have been in the identification of gang members, gang activity and trends and gang interdiction initiatives.

- Experience in the areas of social work and/or guidance and counseling may substitute for up to four (4) years of the required experience in corrections and/or law enforcement.
- A degree in any field from an accredited college or university may substitute for the required experience on a year for year basis.

### ***Essential Duties and Responsibilities\****

- Maintains daily systems monitoring of all NMCD STIU Units, to include all privately operated facilities.
- Conducts daily review of STIU program to ensure compliance with policy and implementation of intelligence gathering procedures.
- Conducts daily analysis of verbal or written group or gang related intelligence information for comprehensiveness and for coordination of STIU tactical or strategic operations.
- Coordinates the activation of STIU for response and support at targeted institutions where intelligence information indicates potential group or gang related problems, and/or security threats by providing on-site management of staff resources.
