

# **CORRECTIONAL OFFICER SPECIALIST – RECREATION**

# General Summary

Correctional Officer Specialists work within a specific operations and maintenance specialty, in addition to working as a Correctional Officer. The purpose of this position is to provide inmate supervision during recreational activities.

## Distinguishing Characteristics

This is the sole level of the Correctional Officer Specialist – Recreation position.

## Recommended Education and Experience for Full Performance

High School Diploma or equivalency and one (1) year as a Correctional Officer.

## Minimum Qualifications

High School Diploma or equivalency and six (6) months as a Correctional Officer.

## Essential Duties and Responsibilities\*

- Supervises the daily inmate activities of up to 80 inmates per recreational period, during indoor recreational periods, and ensures a safe and secure environment.
- Supervises the work and records of the Canteen Clerk, and prepares the purchase orders for recreational equipment.
- Supervises inmates when required.
- Supervises the work of the inmate porters while they clean, repair, exercise equipment and paint.
- Maintains Hobby Shop purchases and oversees Hobby Shop inventory.
- May be required to supervise inmates' work and perform the duties of other trades as required.

#### Bargaining Unit: Correctional Officer Specialist - Recreation: May be represented.

#### Statutory Requirements: None.

**Conditions of Employment:** This position is safety sensitive. Employment is subject to a pre-employment and random drug testing in accordance with all terms and conditions of federal and state rules and regulations regarding alcohol and/or drug testing. Must have successfully completed the New Mexico Corrections Academy. Must possess and maintain a valid New Mexico Driver's License. The applicant must be a U.S. citizen, must be at least 18 years old, have a least a high school education or its equivalent, be of good moral character, have not been convicted of a felony in the courts of this or any state or in the federal courts, and successfully pass any physical and aptitude examination the department may require. Employment is subject to a pre-employment background investigation and is conditional pending results.

Working Conditions: Work is performed in a prison setting with inmate contact and supervision of inmates.
