General Summary

Dentists provide dental services to patients in a state facility or public health program. Dentist perform examinations to determine and deliver treatment. Employees plan and conduct dental health education and clinical treatment programs and serve as consultant to health units or other medical and paramedical services in a state facility, clinic, or community health agency.

Distinguishing Characteristics

This is the full performance practicing Dentist. This position supervises clinical staff.**

Recommended Education and Experience for Full Performance

Dental Degree (DDS or DMD) from an accredited dental college or university, current license as a Dentist in the State of New Mexico issued by the New Mexico Board of Dental Health Care and six (6) years of experience as it pertains to the essential duties and responsibilities of the classification AND two (2) years or experience as a Supervisor.

Minimum Qualifications

Dental Degree (DDS or DMD) from an accredited dental college or university, current license as a Dentist in the State of New Mexico issued by the New Mexico Board of Dental Health Care and four (4) years of experience as it pertains to the essential duties and responsibilities of the classification.

Essential Duties and Responsibilities*

- Direction, supervision and provision of comprehensive clinical dental treatment.
- Requires working knowledge of complex medical issues and how to modify treatment technique to safely treat individuals.
- Requires extensive working knowledge of behavioral support techniques for individuals with complex psychosocial profiles and complicated medical comorbidities.
- Supervises Dental Hygienists and Dental Assistants.
- May provide supervision of other program personnel.
- Provides clinical procedures such as diagnostic, preventive, restorative and oral surgery and ensures compliance with applicable rules, regulations and mandates.
- Monitors clients' oral functions, diseases and treatment plans and provides documentation of the diagnosis and consultation.
- Evaluates patient's medical and behavioral histories to ensure appropriate care.
- Participates in the dental public health program.
- Prescribes medications to patients and carries out disease prevention programs.
