

# PHYSICIAN – EMERGENCY MEDICINE

# General Summary

Emergency Medicine Physicians provide first line response, initiate resuscitation and stabilization, and investigate and order interventions enabling a diagnosis and treatment of the acutely ill patient, regardless of age. Physicians work as part of a team with other specialty physicians and members of the emergency department staff. Emergency physicians must evaluate a wide variety of ailments, and they must be able to think and act quickly to make a tentative diagnosis and determine the appropriate course of treatment.

First level Emergency Medicine Physician provides medical treatment to patients requiring acute and life-saving care. - Manages and/or consults on clinically complex cases. Directs patient care in emergency room settings.
- Performs discharge planning taking into consideration patient environment and skills.

### Recommended Education and Experience for Full Performance

Requires a license to practice medicine in New Mexico and six (6) years of experience as it pertains to the essential duties and responsibilities of the classification. Emergency Medicine Board Certified, possess an active controlled substance license and DEA registration in New Mexico.

### Minimum Qualifications

Requires a license to practice medicine in New Mexico and two (2) years of experience as it pertains to the essential duties and responsibilities of the classification. Emergency Medicine Board Certification, possess an active controlled substance license and DEA registration in New Mexico.

## Emergency Medicine Physician Level III

#### Distinguishing Characteristics

Senior level Emergency Medicine Physician provides medical treatment to patients requiring acute and lifesaving care. In addition to fulfilling the duties of a practicing Physician, incumbents at this level are accountable for mentoring of Physicians at the first and second level, acting as a Chief of Staff Physician (elected by their peers on a rotational basis), and may act as the Medical Director for a designated facility.

#### Recommended Education and Experience for Full Performance

Requires a license to practice medicine in New Mexico and ten (10) years of experience as it pertains to the essential duties and responsibilities of the classification. Emergency Medicine Board Certification. Possess an active controlled substance license and DEA registration in New Mexico.

#### Minimum Qualifications

Requires a license to practice medicine in New Mexico and six (6) years of experience as it pertains to the essential duties and responsibilities of the classification. Emergency Medicine Board Certification, possess an active controlled substance license and DEA registration in New Mexico.

# PHYSICIAN – EMERGENCY MEDICINE

### Essential Duties and Responsibilities\*

- Performs all duties of an Emergency Medicine Physician Level II.
- Plans, organizes and directs hospital staff and activities within the department of Emergency Medicine.
- May oversee, train, and evaluate work of medical and nursing staff.
- Responsible for the development and monitoring of performance within the department to maintain quality control.
- Participates in departmental activities to comply with accreditation and regulatory standards.
- Works closely with hospital staff, departmental directors and physicians to ensure high standards of quality and safety within the Emergency department.
- Accountable for all required documentation in accordance with medical policies, practices and protocols.
- Reviews treatment plans, clerical records, diagnoses, and patient-release proposals for quality and adherence to facility or institution policy

**Statutory Requirements: S**tatutory requirements for individual positions in this classification will vary based on each agency's utilization, essential functions and the recruitment needs at the time a vacancy is posted including. It is the hiring Agencies responsibility to ensure the appropriate licenses/certifications are obtained for each position.
