Minimum Skills, Education, and Experience:

High School Diploma or Equivalency and two (2) years of experience in investigations, regulation, policy, statutory, and/or contract compliance.

COMPLIANCE OFFICER - ADVANCED

Location: Santa Fe, Raton, and Aztec

Minimum Skills, Education, and Experience:

Bachelor's degree in Business Administration and two (2) years of experience in investigations, regulation, policy, statutory, and/or contract compliance. Any combination of education from an accredited college or university in a related field and/or direct experience in this occupation totaling six (6) years may substitute for the required education and experience.

ADMINISTRATION AND COMPLIANCE BUREAU CHIEF

Location: Santa Fe

Minimum Skills, Education, and Experience:

A Bachelor's Degree in any field of study from an accredited college or university and six (6) years of professional level experience with a tactical impact directly related to the purpose of the position defined by the agency at the time of recruitment. Any combination of education from an accredited college or university in a related field and/or direct experience in this occupation totaling five (5) years may substitute for the required education and experience.

TIMBER MANAGEMENT OFFICER

Minimum Skills, Education, and Experience:

Bachelor's degree in Forestry, Range Management, or Ecology and three (3) years of experience in Forestry, Range Management, Forest Management, Natural Resources, Wildlife Science, Fire Science or Ecology. Any combination of education from an accredited college or university in a related field and/or direct experience in this occupation totaling seven (7) years may substitute for the required education and experience.

CLEAN ENERGY ANALYST

Location: Santa Fe

Minimum Skills, Education, and Experience:

Associates degree and two (2) years of experience in the procedures of business and management principles involved in strategic planning. Any combination of education from an accredited college or university in a related field and/or direct experience in this occupation totaling four (4) years may substitute for the required education and experience.

FINANCIAL COORDINATOR - ADVANCED

Location: Santa Fe

Minimum Skills, Education, and Experience:

Bachelor's degree in Finance, Accounting, Economics, or Business Administration and five (5) years of directly related experience in budgeting, accounting and/or auditing. Any combination of education from an accredited college or university in a related field and/or direct experience in this occupation totaling nine (9) years may substitute for the required education and experience. For use at the State Investment Council only: any budgeting, accounting and/or auditing experience is acceptable.

ATTY IV

Location: Santa Fe

Minimum Skills, Education, and Experience:

Juris Doctorate degree from an accredited school of law and five (5) years of experience in the practice of law. Must be licensed as an attorney by the Supreme Court of New Mexico or qualified to apply for limited practice license (Rules 15- 301.1 and 15-301.2 NMRA).
