- Cleans and sanitizes work and lab area and observes safety procedures as mandated by State policy and the Occupational Safety and Health Administration (OSHA).
- Stocks, inventories, and orders supplies.

Essential Duties and Responsibilities*

- Acts upon leave requests, conducts annual performance evaluations and recommends disciplinary actions.
- Interviews and recommends selection of applicants and conducts the training of personnel.
- Provides training and technical assistance to less experienced staff.
- Oversees the drawing of blood, collection of specimen samples, labeling of collection containers, and transporting of samples to laboratory facilities.
- Monitors vital signs of the patient by checking blood pressure and heart rate.
- May perform EKG testing.
- Confirms test results are communicated to assigned medical staff.
- Ensures accurate patient records are maintained.
- Ensures labeling and biohazard materials are properly disposed of.
- Ensures work and lab areas are cleaned and sanitized and laboratory safety procedures as mandated by State policy and the Occupational Safety and Health Administration (OSHA) are followed.
- Certifies that stocks, inventories, and supplies have been ordered.
