CPS Investigation Case Worker: Incumbent will investigate child abuse and neglect referrals, assess the risk and safety of the child and take appropriate action, provide testimony in court, and prepare cases for transfer to CPS Permanency Planning.

Minimum qualifications: Bachelor's Degree in Social Work, Education, Counseling, Psychology, Sociology, Criminal Justice or Family Studies from an accredited college/university and two (2) years of any combination of experience including working with communities on health or social service related matters, social work/case management experience, behavioral health and/or health care. Hourly Salary: \$20.36 to \$32.58.

CPS Placement Case Worker: Incumbent will coordinate and facilitate the placement of children in CYFD custody by studying families interested in becoming foster and adoptive families.

Minimum qualifications: Bachelor's Degree in Social Work from an accredited college/university and licensure by the New Mexico Board of Social Work Examiners at the LBSW, LMSW or LCSW level or eligibility for such licensure in accordance with NM requirements OR a Bachelor's Degree in Social Work, Education, Counseling, Psychology, Sociology, Criminal Justice or Family Studies from an accredited college/university and two (2) years of any combination of experience including working with communities on health or social service related matters, social work/case management experience, behavioral health and/or health care. Hourly Salary: \$17.94 to \$28.70.

CPS Permanency Planning Case Worker: Incumbent will coordinate assessments and permanency plans for children in CYFD custody to promote child safety, permanency and well-being.

Minimum qualifications: Bachelor's Degree in Social Work, Education, Counseling, Psychology, Sociology, Criminal Justice or Family Studies from an accredited college/university. Hourly Salary: \$17.94 to \$28.70.

In-Home Services Practitioner: Incumbent will provide in-home services for Protective Services Clients by developing and implementing interventions with children and families receiving voluntary services to reduce risk and promote safety of children who are experienced or may be at risk of experiencing child maltreatment.

Minimum qualifications: Master's degree in Social Work, Guidance and Counseling, Counseling, Psychology, Sociology or Criminology from an accredited college/university is required for this position and two (2) years of any combination of experience including working with communities, working on health or social service related matters, social work/case management experience, behavioral health and/or health care. Must possess a current license in New Mexico as a Doctoral Level Psychologist, Psychologist Associate, LISW, LMSW, LPC, LPCC, LMHC or LMFT or eligibility for such licensure in accordance with New Mexico requirements. Hourly salary: \$20.36 to \$32.58.
